ORDER

As per the Government orders read above, orders were issued that the Kerala Paramedical Council shall issue Certificate of Registration to Paramedical Certificate holders of those courses conducted by the Director of Medical Education/Director of Health Services and to B.Sc (MLT) and M.Sc (MLT) degree holders from the Kerala, Mahatma Gandhi, Calicut and Kannur Universities. Based on clarification sought by the Director of Medical Education as per letter read as fourth paper above, the Paramedical Council in its meeting held on 27.09.11 recommended Government to grant

- i. registration to MLT diploma/degree holders possessing Paramedical Council registration if they acquire higher qualification i.e. diploma holders acquiring degree/post graduate degree and degree holders the post graduate degree by levying Rs.300/- and
 - ii. registration to M.Sc.MLT degree holders from Universities of the State with B.Sc. MLT from Universities of other states by levying Rs.500/-
2. Government after examining the case in detail are pleased to accept the recommendation of the Council without any modifications. The Director of Medical Education shall suitably modify the application proforma for Registration as Paramedical Professional already published in the official website of Paramedical Council www.keralaparamedicalcouncil.org.
3. The application in duplicate downloaded from the website viz, www.keralaparamedicalcouncil.org, with the prescribed fee shall be submitted to the Director of Medical Education, Thiruvananthapuram. The Director of Medical Education shall refer the application to the Registrar, University concerned and issue Registration Certificate, on receipt of the authenticity of the Degree Certificate.
