ORDER

As per the Government order read above, admission to the Paramedical Diploma, during 2010-11 was entrusted through LBS by online process. The Director of Medical Education has reported that 355 seats are vacant in Government Medical Colleges and other Self Financing institutions. The Director of Medical Education is therefore permitted to invite fresh applications from eligible candidates including SC/ST category to prepare Supplementary Rank list through LBS Centre, Thiruvananthapuram for admission to Professional Diploma courses (D.Pharm, Health Inspector and Paramedical Diploma Courses) for academic year 2010-11, so as to fill the vacant seats, in relaxation of the relevant clause in the Prospectus for Professional Diploma courses 2010, approved as per Government order read as 1st paper above. The Director of Medical Education/ Director, LBS Centre shall take steps to fill the vacant Management seats in the Self financing institutions for Diploma in Health Inspector course, along with merit seats from the Rank list, and that the Management seat students shall be admitted on Government fees.


2. The admission to Professional Diploma courses for academic year 2010-11 shall be closed on 31.01.2011 and Director, LBS Centre/Director of Medical Education shall ensure conduct of admission and allotment of students within the time frame.
